**APPROVE 2003-04 APPROPRIATION ADJUSTMENT TO FUND THE STATEWIDE
SPECIAL ELECTION FOR THE DEPARTMENT OF REGISTRAR-
RECORDER/COUNTY CLERK
(ALL DISTRICTS) (4 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

Approve the attached appropriation adjustment appropriating \$13.4 million in anticipated over-realized recording fee revenue to fund the October 7, 2003 Statewide Special Election.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION:

The Registrar-Recorder/County Clerk (RR/CC) is requesting Board approval of a \$13.4 million increase in appropriation authority to fund unanticipated expenditures in overtime, staffing, and services and supplies to conduct the October 7, 2003 Statewide Special Election. In addition to the recall election, this election will also include 2 statewide measures.

On Wednesday, July 23, 2003, the Secretary of State certified a gubernatorial recall election, the first in California history, and on Thursday, July 24, 2003, the Lieutenant Governor issued his proclamation announcing the Statewide Special Election was to be held on October 7, 2003.

The \$13.4 million estimated cost to conduct this election consists primarily of \$7.2 million in Salaries and Employee benefits due to projected increases in temporary staffing (\$5.7 million) and overtime usage (\$1.5 million). Additionally, we are projecting \$6.2 million in Services and Supplies costs primarily attributable to pollworker salaries, official and sample ballots, multilingual and translation, campaign reporting, postage and election supplies, vote recorder pages, and supply delivery.

Implementation of Strategic Plan Goals:

This request supports the County's Strategic Plan as follows:

Goal No. 1: Service Excellence: To reliably and consistently provide the registered voters of Los Angeles County with easy access to critical election services and information.

Goal No. 4: Fiscal Responsibility: Strengthen the County's fiscal capacity. Manage effectively the resources we have by realigning appropriation and estimated revenues to appropriately fund unanticipated State-mandated election requirements.

FISCAL IMPACT/FINANCING

The requested \$13.4 million appropriation adjustment is fully funded by anticipated over-realized recording fee revenues resulting from a projected continuation of heightened refinancing activity in the real estate market. This requested action would not increase net County cost.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The requested appropriation adjustment appropriating \$13.4 million in anticipated over-realized recording fee revenue allows the RR/CC to conduct the October 7, 2003 Statewide Special Election.
